Contract period January 1, 2019 – December 31, 2019 – With six one-year renewable options

<u>Discount</u> Tier 1 - \$1.00 to \$10,000 47% Off List Tier 2 - \$10,001 to \$30,000 49% Off List

**Tier 3 -** \$30,001 to \$50,000 51% Off List \$50,001 and Above Negotiable

<u>Purchase Orders</u> –State Agencies orders are sent directly to HPFI Authorized Dealer

<u>Payment</u> – Checks, directly to authorized dealer or Agency may use the Arkansas State Purchasing Card (P-Card) to purchase furniture

<u>Delivery, Installation and Fees</u> – Delivery type must be specified on Agency Purchase Order. Delivery and Installation charges will be quoted on a per project bases and added as a separate line on the invoice.

- <u>Drop Shipped</u> Off loaded by carrier to and Agency loading dock or designated area. There will be no charge to the ordering Agency for this delivery method.
- <u>Inside Delivery</u> Off loaded, un-boxed and placed in pre-determined locations within the building. Dealer will be responsible for the removal of any trash, packaging materials, and cartons associated with delivery.
- <u>Delivered and Installed</u> Off loaded, and installed. Installation shall include but not limited to; any and all labor, material, and tools necessary to install furniture in accordance with approved plans and specifications and/or the direction of authorized agency personnel. The installation company will be responsible for the removal of any trash, packing material, and cartons associated with their installation.

<u>Taxes</u> – Most Arkansas agencies must pay state sales tax. Before billing, the dealer should contact the ordering agency to find out if that agency must pay sales tax. Itemize state sales tax on invoice when applicable.

Minimum Order 500 lbs - Add \$75 for less that minimum order
